## Wisconsin Federal Employee Trudy Givens Wins National SAVE Award and Meets with President Obama to Discuss Her SAVE Idea

Congratulations to Trudy Givens of Portage, Wisconsin, the 2010 SAVE (Securing Americans' Value and Efficiency) Award Winner! Thousands of Federal employees submitted their ideas to streamline government and save your tax dollars. Thousands of citizens voted for four finalists. Out of more than 18,000 ideas, all of which were read and helped inform your government, Trudy's idea earned her an opportunity to meet the President and discuss her idea.



### WELCOMING THE 2010 SAVE WINNER TO THE WHITE HOUSE

On Tuesday night, January 25, 2011, President Obama spoke about giving the American people a government that's not only more affordable, but also more effective and more efficient. Federal employees are important partners in that effort. From inspecting the food heading to our tables and making sure Social Security checks go out on time to treating wounded troops and helping returning Veterans pursue higher education, Federal employees are working day in and day out to serve the American people. The President believes these frontline workers are essential to any effort to improve government.

The <u>SAVE Award</u> was implemented in 2009 to gather ideas from employees across the country about how to cut waste and make government work smarter for the American people. On Friday, January 28, 2011, the President met with the employee who the public voted the 2010 winner: Trudy Givens of Portage, Wisconsin.

Trudy is a 19-year employee of the Bureau of Prisons, currently serving as a Business Administrator at the Federal Correctional Institution in Oxford, Wisconsin. Over the course of her career, Trudy noticed that several copies of the *Federal Register* — the federal government's official daily publication for rules, proposed rules, and notices from Federal agencies and organizations, as well as executive orders and other presidential documents— were delivered to her workplace several times per week, but employees rarely referenced the documents. The *Federal Register* was made available online years ago, and most

members of the interested public reference that online version now. Trudy thought that in keeping with the President's spirit of cutting out waste and going green, the government should cease the printing and mailing of thousands of *Federal Registers* to employees who don't need them.

Even ideas that sound small can add up. Printing just one page of the *Federal Register* costs a little more than a penny, but when you amplify that across the whole of government, suddenly your talking millions of dollars. We expect to save the vast majority of those dollars – at current costs that could be up to \$4 million dollars per year-- by limiting print distribution to those who need it.

And Trudy's not alone. Employees across the government are contributing ideas to make their agency work more effectively and efficiently. Through the SAVE competition, we are starting to see a cultural shift where employees are really becoming engaged in rooting out waste. Several agencies including the Departments of Housing and Urban Development, Interior, and Defense have launched their own internal competitions or online engagement tools to encourage employees to submit their ideas to save money and make government work more efficiently and effectively all year round.

It is incumbent upon all of us in public service to be conscientious stewards of your taxpayer dollars. But it is particularly important to do so when the fiscal times are tough. Congratulations, Trudy, for winning this year's award, and thank you for your contribution to making the government more effective and efficient.



That's why in 2009 he launched the SAVE Award (Securing Americans' Value and Efficiency), seeking ideas from frontline federal employees to make government more effective and efficient and ensure taxpayer dollars are spent wisely. The three finalist teams, which included North Carolina State University and the University of Wisconsin - Platteville, did an outstanding job with their reports and presentations at AGA's Ninth Annual National Leadership Conference in Washington, D.C. All teams constructed a Citizen-Centric Report for the fictional city of Pepperdom, VA. The 2011–2012 competition will begin in October 2011. Learn more.

The best undergraduate accounting/financial management/business students in the country were invited to compete in the fourth annual Government Finance Case Challenge, sponsored by the Association of Government Accountants (AGA).

Student teams collaboratively analyzed and offer a written response to a case centered on how a U.S. city government creates a citizen-centric report. All members of the three highest-scoring teams received a scholarship to attend AGA's National Leadership Conference, set for February 17-18, 2011 in Washington, D.C.

Teams presented their finalized solutions before a panel of federal/state/local government leaders, corporate partners and CFOs. The winning teams were announced at the awards luncheon on the final day of the conference. Cash prizes will be awarded to the winning team. Each student participant will receive a free one-year membership to AGA.

#### From the National Office

After a conference filled with dire predictions about the confounding challenges facing government at all levels, AGA's Ninth Annual National Leadership Conference ended Friday on an optimistic note with an address from Office of Management and Budget Controller **Danny Werfel**.

Beginning with a story from his boss, Jeffrey Zients, OMB's deputy director for management and chief performance officer, Werfel talked about law signing ceremonies when the president is surrounded by the heavy hitters who saw the legislation through Congress. There's lots of clapping and handshaking as they celebrate another success in getting a piece of legislation



to the president's desk. When it's over, everyone walks away. The message Zients left with Werfel is that's when the real work begins.

"The paradigm is that the work hasn't even begun yet, and that the execution is the critical element of that new program or policy," Werfel said, adding that he's been thinking a lot about that paradigm during the budget debates that are dominating the headlines this week.

His focus is on the federal work force, which takes the brunt of the criticism when things go wrong and unfairly symbolizes inefficiencies in government. This same work force will be responsible for carrying out whatever budget level is determined in a way that minimizes disruption of services to citizens.

"That is our job sometimes in the federal work force—to be the ones who take the punches," he said. "But it's what we signed on for, and I'm proud to be a part of it." Read more from Werfel.

## Census: Near-Record Level of U.S. Counties Dying

In America's once-thriving coal country, 87-year-old Ed Shepard laments a prosperous era gone by, when shoppers lined the streets and government lent a helping hand. Now, here as in one-fourth of all U.S. counties, West Virginia's graying residents are slowly dying off.

Hit by an aging population and a poor economy, a near-record number of U.S. counties are experiencing more deaths than births in their communities, a phenomenon demographers call "natural decrease."

Years in the making, the problem is spreading amid a prolonged job slump and a push by Republicans in Congress to downsize government and federal spending.

"You're the anchors of our Main Streets," President Barack Obama told

small business leaders in Cleveland on Tuesday. "We want your stories - your successes, your failures, what barriers you're seeing out there to expand. How can America help you succeed so that you can help America succeed?" - Associated Press. Read more.

## **Decline in Bond Market Has States Nervous**

Illinois plans to sell \$3.7 billion in pension obligation bonds this week, as part of Governor Pat Quinn's plan to address the state's persistent budget deficits.

The last three months have not been pretty in the municipal bond market. Spooked by predictions of government bankruptcies and defaults, investors - especially those in big mutual funds - have fled the field, selling off \$20 billion worth of state and local bonds in the process. The exodus, in turn, has left states that need to borrow wary. The number of new offerings from state and local governments is down to a level not seen in 11 years.

Basically, as panicked investors sell off their old bonds on the street, states have not restocked the shelves in the market by issuing new ones.

All this turmoil could cost taxpayers money. Interest rates on the highest-rated

municipal bonds are up by more than one-third since late August, notes Kinney Poynter, the director of the National Association of State Auditors, Comptrollers and Treasurers. As rates go up, states have to pay more to issue their debt,' Poynter says, 'which means citizens have to pay more for infrastructure projects like roads, schools, etc. So it's had a dramatic effect.' - Daniel C. Vock, Stateline. Read more.

#### GASB Proposes Guidance for Applying Termination of Hedge Accounting Provisions

The Governmental Accounting
Standards Board (GASB) issued its
Exposure Draft (ED), Derivative
Instruments: Application of Hedge
Accounting Termination Provisions (an amendment of GASB Statement No. 53).
The deadline for submitting written comments on the ED is April 15, 2011.

GASB Statement No. 53, Accounting and Financial Reporting for Derivative Instruments, provides for the use of hedge accounting for derivatives that are effective hedges. Hedge accounting entails reporting fair value changes of a





hedging derivative as either deferred inflows or deferred outflows of resources, rather than recognizing those changes in investment income. The Statement requires that hedge accounting cease, and all accumulated deferred amounts be reported in investment income, when a hedging derivative is terminated. *Read more.* 

# Study: One-fourth of Federal Websites Surveyed Rank High in Transparency

A quarter of federal websites surveyed scored high in online transparency, which also was found to be associated with high ratings for customer satisfaction and participation, according to a new study from the research firm ForeSee Results.

For the eight of 32 federal websites that scored 80 or higher on a 100-point transparency scale in 2010, there is a strong correlation with customers being more satisfied, more likely to rely on the website as a primary resource of information and more likely to recommend the website to others, Foresee said in a report issued Feb. 22.

Top-scoring agencies for the fourth quarter of 2010 included the U.S. Citizenship and Immigration Services agency, National Oceanic and Atmospheric Administration,

Navy, Air Force and the National Human Genome Research Institute. - Alice Lipowicz, *Federal Computer Week*. <u>Read more.</u>

## Federal Agencies, Contractors Preparing for Government Shutdown

Federal agencies continued reviewing shutdown plans Wednesday in anticipation of a possible closure of the federal government that could begin as early as next week.

Most of this week's planning probably revolves around determining which employees would need to work, according to Barry Anderson, a budget expert who handled shutdown-related concerns for the Office of Management and Budget during the Clinton-era closures.

A series of memos written by Attorney General Benjamin Civiletti in the closing days of Jimmy Carter's administration still dictate how agencies should make those determinations. Federal programs drawing funds from annual appropriations should continue to operate if there is a "reasonable and articulable connection between the function to be performed and the safety of human life or the protection of property," Civiletti wrote. - Ed O'Keefe, *The Washington Post. 
