# January 15, 2014: Fraud Detection & Prevention: Using Technology for Auditing – AGA National Web Conference

Identifying fraud within the billions of dollars spent on public programs on a case-by-case basis is like searching for needle in a haystack. But new technology allows auditors to sift through all of the spending and to identify patterns outside the norm. Bringing in information from other systems provides more penetrating insight and allows investigators to focus time and energy more productively and meaningfully.

The Massachusetts State Auditor's Office has employed data analytics tools to make risk-based audit selections, enhance risk analysis in audits, and conduct data-driven, proactive investigations. This web conference will examine the case of a doctor's fraudulent billing of the state health program to illustrate the value of these tools. You will hear the story of how they uncovered the fraud as the team takes you through the investigative process step-by-step.

### June 11, 2014: Understanding the DATA Act – AGA National Web Conference

On May 9, President Obama signed into law the Digital Accountability and Transparency Act, which passed Congress with bipartisan support. The law requires federal agencies to publish spending information in a standardized format that will be accessible to the public. The DATA Act has the potential to make federal expenditures more transparent and easy to analyze by interested parties. It has implications for federal agencies and recipients of federal grant funds.

## 4. Community Service:

Our chapter held specialized drives at the September, October, November, and March lunch meetings to collect seasonal items needed by the Salvation Army Community Center and Homeless Shelter. We collected over 50 backpacks, 40 pairs of warm socks, and 100 diapers. We held food drives at the January and April meetings. We also collected cash donations and collected paper bags to help out the MOM Food Pantry in Middleton. Members were also invited to bring small sized toiletries for the Salvation Army homeless shelter to any meeting. Two members participated in the Volunteer Income Tax Assistance Program, totaling over 100 hours. The chapter had a team participate in the MS Walk on May 5, 2014. Our team included 1 member and 3 non-members. The team raised over \$700 in donations. The chapter donated \$110 for selected WI products to go the PDC for the National Community Service Fund (NCSF) raffle.

The chapter made the following cash donations during the program year: \$300 to the Second Harvest Food Bank.

#### 5. CGFM Activities:

We published articles in each newsletter related to the certification and offered reimbursement to the first 4 people to pass the exam. This year, we had several members start the review process, but no one sat for any exams.

We were once again able to get a Governor's Declaration that March was CGFM month. We received a signed certificate from Scott Walker, Governor, State of Wisconsin. We were also able to get a certificate from the Mayor of Madison. The two proclamations were displayed and highlighted at the March 20 lunch meeting and May 14 Symposium. CGFM holders who came to the March lunch received a free lunch. At our March 21 luncheon meeting and the May 7 Symposium, all CGFM holders received a special CGFM sticker for their name badge to highlight their professional achievement. A photo was taken of the CGFMs and the proclamations for the newsletter.
