Web Conference: Understanding the DATA Act

June 11 | 1-2:50 p.m. ET | 2 CPEs Available

On May 9, President Obama signed into law the Digital Accountability and Transparency Act, which passed Congress with bipartisan support. The law requires federal agencies to publish spending information in a standardized format that will be accessible to the public. The DATA Act has the potential to make federal expenditures more transparent and easy to analyze by interested parties. It has implications for federal agencies and recipients of federal grant funds.

This web conference will provide an overview of the law's major provisions and the first steps toward implementation.

April Lunch Recap Budget and Estimated Impact on Operations Alliant Energy Center Construction

The Alliant Energy Center is a 164 acre multi-use complex. The full campus is called the Alliant Energy Center (AEC). Components include: the 8,500 seat Coliseum, the 155,000 square foot Exposition Hall, multi-species livestock facilities, hockey capabilities. The AEC has 30 full-time employees and 200 part-time.

The AEC hosts about 500 events each year with an average of 1,000,000 people coming through the campus. The event composition is:

- 4% meetings and banquets
- 12% sports
- 21% concerts and touring shows
- 24% conventions and trade shows
- 39% consumer shows

The economic impact includes 75,0-00 hotel room nights for \$2.1M of room taxes.

Financial Operations

The AEC is part of the Dane County general fund. It is self-financed for personnel, capital improvements, and operations. The operating budget is \$8M. They have been drawing down their reserves to cover the bad years since 2005. The economy is starting to turn for them.

AEC broke ground in early April on the new barns area. This was done in full cooperation with customers/partners: the horse assns, Dairy Expo, UW, and County government all agreed with the planned construction. The 11 old barns were torn down. They will build two premanufactured metal pavilions with multi-use capability. One will be heated

for year-round use and the other will be tempered for use 8 months of the year. The 8 acre area wasted a lot of land space in the past. The 2 new buildings will have far more capacity and use (first is 90,000 square ft and second is 200,000 square feet). They were able to put in environmentally friendly plans for manure storage and washing pens. They will collect rain water and pipe it down to Willow Island, which acts as a natural filter. These are not barns; these are showcase pavilions.

Construction has to be completed within 30 weeks. The facilities have to be set for the World Dairy Expo. They are tracking time in hours, not weeks.

This is a \$24M project with \$9M State of Wisconsin funding and contributions from:

- \$3M World Dairy Expo
- \$1M Midwest Horse Fair
- \$1.5M New Holland (naming rights)

The project includes \$153,961 for restrooms upgrade.

New Business from Project

AEC already has received \$185,000 in new business, even before the groundbreaking. They are starting to fill up dates fast. With the new capacity, they can start to market to swap meets, car shows, boat shows.

Tidbits

There is no air conditioning in Pavilions since it can kill cattle to come in from the heat and hit the a/c.

For the County Fair this summer, animals will be in tents since there are no barns.

These positions are located at the WI Department of Revenue, in Madison, Wisconsin, in the Division of Enterprise Services, Financial Management Bureau.

Job Duties:

Under the general direction of the Financial Management Services Bureau Director, serve as Section Chief of the Revenue Accounting Section or Section Chief of the Lottery Financial Operations Section. The Revenue Accounting Section Chief supervises three Accountants and two Financial Specialists. The Department collects over \$11 billion in tax revenues and distributes over \$400 million dollars in local taxes to local taxing authorities, and over \$1.5 billion dollars in shared revenue payments to Wisconsin municipalities. The Revenue Accounting Section Chief is responsible for maintaining the integrity of financial transactions, including accounting for all tax revenues, refundable tax credit expenditures, tax distributions and refunds, as well related financial reporting.

The Lottery and Financial Operations Section chief supervises four Accountants and one Financial Specialist. The Department collects over \$11 billion in tax revenues and distributes over \$400 million dollars in local taxes to local taxing authorities, and over \$1.5 billion dollars in shared revenue payments to Wisconsin municipalities. The Lottery and Financial Operations Section Chief is responsible for maintaining the integrity of financial transactions, including accounting for lottery and other administrative revenues, expenditures and related financial reporting.

Both Positions require in-depth knowledge of governmental accounting, planning and operating aspects of financial systems and procedures, GAAP accounting as well as relevant Wisconsin Statutes and Department of Revenue policies and procedures.
