Recap Of November Luncheon Meeting OpenBook Wisconsin Scott Thornton, DOA

The state of Wisconsin has a transparency website to look up state agency expenditures. If you have not visited, it is an interesting and easy to use site to look at. http://openbook.wi.gov/
Expenditures can be searched by fiscal year and agency, vendor, or category.

Mr. Thornton gave a history of the laws that brought the site into being, discussed all the items covered, and how inquiries can be made.
