Speaker Biographies

Tony Scardino is Vice President, Internal Audit, at Crowdstrike. Prior to that, he was a Vice President with CGI Federal, where he helped federal agencies solve organizational, financial, and IT challenges. Previous to this position, Tony served as Managing Principal at Grant Thornton, where he led the firm's cadre of former government executives (FGEs) that leveraged its experience and expertise to help agencies work across the C-suite to improve mission outcomes, provide excellent service, and effectively steward taxpayer dollars.

Until July 2019, Tony was the Chief Financial Officer for the United States Patent and Trademark Office (USPTO), serving as principal advisor to the USPTO Director in leading and improving the financial management, accounting, budgeting, fee setting, revenue forecasting, financial systems, and organizational performance of the agency. In this role, Tony oversaw an annual budget that exceeded \$3 billion, supporting almost 13,000 USPTO employees. Tony also spent much of 2017 and 2018 as the agency's Acting Deputy Director. His prior experience includes service as the Budget Director/Acting CFO at the Department of Housing and Urban Development (HUD) and the Budget Director for former agency known as the Broadcasting Board of Governors (BBG).

In recognition of his achievements, Tony has been the recipient of numerous awards and distinctions, including the Meritorious Presidential Rank Award (2014), the Frank Greathouse National Leadership Award from AGA (2017), and American University's Roger W Jones Award for Executive Leadership (2018). In November 2017, Tony was inducted as a lifelong Fellow into the National Academy of Public Administration (NAPA).

Tony is currently a member of the AGA National Governing Board. He serves as a Director At-Large. He is a frequent speaker and moderator at AGA national conferences.

David Erdman is a Managing Director for Baker Tilly Municipal Advisors, LLC. He has over 30 years of public finance experience at a major state-level issuer and is an active advocate and leader for municipalities in the municipal bond market. David is a part of the national large issuer team supporting the Midwest.

They also held other senior roles at the Agency, including Principal White House Liaison for Environmental Protection Budgeting, where they led the ERM and financial implementation of EPA's climate change, sustainability, and climate and environmental justice initiatives, and Chief of Staff for Chemical and Waste Risk Management under the Great Lakes Restoration Initiative, where they led cross-government chemical and waste risk management collaborations. Prior to EPA, they also worked at the U.S. Department of Energy's Argonne National Laboratory, leading a team focused on climate risk management in Chicagoland.

Outside of their government work, Brad is an Adjunct Lecturer at Northwestern University, focusing on strategic communication, program evaluation, and ERM in the public sector, and leading the institution's Affinity Leaders and Learners (ALL) mentoring program. They also mentor students pursuing sustainability and ERM careers at The University of Chicago, Princeton University, Harvard University, and Yale University. They are a CGFM and hold degrees in Chemistry and Environmental Studies, both from the University of Chicago (AB/SB, 2005), and a Master of Public Policy and Administration (MPPA) degree from Northwestern University (2017), where they focused on global voluntary climate, energy, and environmental policy development. They also hold certificates in Executive Leadership in Sustainability from Harvard University, and Clean Energy Financing from Yale University.
